

Center Elementary School Details:

- New construction
- Opening January 5, 2023
- 140,603 square feet on three floors
- 750 students, grades 2, 3, and 4
- Center School and Central Office Administration offices, including Food Service and Special Education
- Move period:
 - Late November/early December for Central Office
 - Classrooms, etc. during holiday break

Origin Elementary Schools:
